Submit your compositions

Please complete the Proposal as fully as possible. If full information is not provided, delays or rejections may occur. If the composition has been recorded and issued commercially on any label of the Divine Art Limited group, then we guarantee in most cases to accept publication. All other submissions will be treated entirely on merit.

We will consider your submission as quickly as possible and if accepted, will send you a formal contract. A one-off administration fee is charged of £15.00 per A4 page of the score in final published format **and** of any related instrumental / vocal parts.
